1. All correspondence and documentation will be sent to the lead passenger only and it is their responsibility to manage their booking and inform others in their group.
2. Upon receipt of your booking form and non-refundable deposit these will represent a contract existing between the lead passenger, all members of their group and Dance Away Promotions
3. The balance monies are due at least 8 weeks prior to the departure date. Should the balance not be paid on time we reserve the right to cancel the booking and retain the deposit. For bookings made within the 8 weeks of the departure date the full cost of the holiday must be paid in full at the time of booking and will be subject to our cancellations policy as stated within these booking conditions.
4. It is an absolute necessity that all persons travelling within your group who are joining our holiday are responsible for their own insurance. Please ensure this covers the full duration of your stay and must include 24 hour emergency telephone, repatriation service and holiday cancellation cover. Your booking is taken on this basis and you must fully understand Dance Away Promotions cannot be held liable under any circumstances. Should you fail to take out adequate insurance cover we will, in an emergency, offer all reasonable assistance but you understand that you will be responsible for any costs involved as a consequence of your failure to take out appropriate insurance.
5. Cancellations made up to 8 weeks prior to the holiday are subject to a cancellation fee of £50. Any cancellations made within 8 weeks of the holiday commencing will be subject to a complete loss of the holiday cost. Any full or partial refund will be solely at the discretion of Dance Away Promotions but your insurance should cover such an eventuality.
